With reference to the letter cited, Fresh / Renewal applications of the Central Sector Scheme of Scholarship for College and University students (UG & PG) for the year 2019-20 should be processed through National Scholarship Portal under Ministry of Human Resource Development (MHRD), New Delhi.

Accordingly, all the applications of the Central Sector Scholarship Scheme for college and University students for the year 2019 (Fresh) and for the year 2016, 2017 and 2018 (Renewal) may submit their application forms with required documents only through the National Scholarship Portal (NSP) <http://www.scholarships.gov.in> on or before **31.10.2019**. The eligible students are advised to apply through proper channel. Guidelines for the scheme are published in the same website.

The common eligibility conditions:

1. Parental / Family Income - Rs.8.00 lakhs per annum.
2. Fresh application - Students scored above 80% of marks in class XII of 10+2 pattern or equivalent and pursuing regular course.
3. Renewal application - Students has secured 60% or more marks in the previous exam with 75% of attendance.

The last date for applying the scholarship for fresh and renewal applications is 31.10.2019.

For further details students are advised to contact Reservation Cell during the working hours.

All the Deans/HODs/Directors/Course Coordinators are requested to inform the students in the department concerned and display it in the **NOTICE BOARD**.


Subject: Opening date for apply for the Central Sector Scheme of Scholarship for College and University Students online on National Scholarship Portal, for fresh and renewals.

The 'Central Sector Scheme of Scholarship for College and University Students' implemented by the Department of Higher Education, Ministry of Human Resource Development would be opened on the National Scholarship Portal <http://www.scholarships.gov.in/> for the Academic Year 2019-20 as per the following schedule:

1	Tentative date of opening	15.07.2019
2	Closing date of receipt of applications	31.10.2019
3	Last date of verification of applications by the Institutions	15.11.2019
4	Last date of verification of applications by the State Education Board	30.11.2019

In light of the above, all students who had applied on National Scholarship Portal and received/yet to receive the scholarship for Fresh 2018, 1st renewal 2017, 2nd renewal 2016 and 3rd renewal 2015 and students who are in the Top 2^{0th} percentile of the respective Boards and who wish to apply for Fresh 2019 scholarship are advised to apply on the National Scholarship Portal for fresh and respective renewal scholarship on or before the last date i.e. 31.10.2019.
