It is informed that online payment of Even Semester fee for the year 2025-26 should be remitted through online mode only using Debit cards/Credit cards/Net Banking and the remittance details are available in our Institute's Student Portal www.portal.ruraluniv.ac.in.

1. **One month time for remittance of even semester fee from the date of commencement of classes for the even semester – 22.12.2025 to 21.01.2026.**
2. **Late fee of Rs.200/- for next 10 days as I Extension from 22.01.2026 to 31.01.2026.**
3. **Late fee of Rs.300/- for next 10 days as II Extension from 01.02.2026 to 10.02.2026.**
4. **Late fee of Rs.1000/- for next 10 days as III Extension from 11.02.2026 to 20.02.2026.**
5. **Final Late fee of Rs.5000/- along with even semester fee for next 30 days from 21.02.2026 to 22.03.2026.**

Further, it is informed that the students **who do not remit their semester fees within the due date will not be permitted to attend the End Semester Examinations.**
