1. Extraordinary Special Supplementary Examinations will be conducted for candidates who have studied various programmes at **Gandhigram Rural Institute, Gandhigram**, from the **1996 CBCS-Regular admission onwards**. Candidates who have not completed their respective programmes of study within **N+2 years** are eligible to appear for the **Extraordinary Special Supplementary Examinations** for Diploma, UG, PG, PG Diploma, and 5-Year & 4-Year Integrated Programmes. This examination will be treated as the **final opportunity**, and no further chance will be provided thereafter. Candidates who have failed in one or more courses are permitted to appear for the **Extraordinary Special Supplementary Examinations to be held in February 2027**.
2. Candidates who wish to appear for the supplementary courses shall enter the courses in the appropriate column provided in the application form and remit the prescribed examination fee. While submitting the application on or before the last date, candidates must enclose the **Bank Challan** as proof of remittance of the examination fee. Candidates should not remit the examination fee after the prescribed last date.
3. The supplementary examination fee shall be remitted to the following account:

Note: Candidates of **Distance Education Programmes (2002–2010)** are **not eligible to apply**.

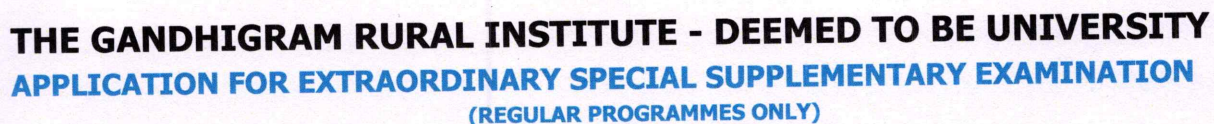
