The meeting started at 10.00 A.M with a minute silent prayer.

At the outset the Secretary, Finance Committee welcomed the Chairman and Members for the 66th meeting of Finance Committee of the Gandhigram Rural Institute (Deemed to be University), Gandhigram and expressed his sincere thankfulness for the continued support of the members for the development of the institute. He requested the Chairman to preside over the meeting.

The Vice-Chancellor and the Chairperson of the Finance Committee welcomed all the members for the 66th meeting of Finance Committee and thanked them for sparing their valuable time for the meeting.

He informed the members that the Institute had secured A++ Grade with 3.58 CGPA out of 4-point scale in the 4th Cycle Accreditations of NAAC. He thanked the

Secretary, Joint Secretary and all officials in Ministry of Education / UGC for extending their guidance and support in achieving the A++ Grade and appreciating for it.

He also informed that with the secured **A++ Grade**, the Institute is submitting various proposal to the different agencies for funding support.

Further, he stated that the admission for the current academic year had been done for 1888 students which higher than the last year. Institute will focus on increasing the student strength with necessary infrastructure facilities like academic buildings / hostels and maintenance of buildings/ campus with the funding support from the Ministry of Education, GoI.

The Chairman thanked the Finance Officer i/c and the Director, CSR for making tremendous efforts in getting the CSR funds sanctioned from the following Bank / Institutions during this financial year.

- 1) IDBI Bank has sanctioned Rs. 92.50 lakh towards construction of Ladies Hostel
- 2) NTPL, Thoothukudi has sanctioned Rs. 15.00 lakh towards Smart Boards for class rooms and Extension Activities in UBA villages in Aspirational Districts Ramanathapuram and Virudhunagar.
- 3) Tamil Nadu Mercantile Bank has sanctioned Rs. 8.00 lakh towards Smart Boards for class rooms of the Institute
- 4) Manapuram Foundation has sanctioned Rs. 4.85 lakh towards installation of Digital Wall for the Institute.
- 5) Lakshmi Foundation has sanctioned Rs. 50.00 lakh towards scholarships to the meritorious students pursuing their Degree in GRI.
- 6) The United Nations has declared 2025 as the International Year of Cooperatives. The Ministry of Cooperation, Government of India has undertaken a range of special initiatives and events to commemorate the International Year of Cooperatives 2025 with the theme "Cooperatives Build a Better World", which was officially launched by the Hon'ble Prime Minister Shri Narendra Modi at the ICA Global Cooperative Conference held in 2024.

In this context, the Institute has held discussions with the Dindigul Central Cooperative Bank, Dindigul to issue ID-cum-ATM cards to first-year students in the initial phase. To facilitate this, students are required to open a Savings Bank (SB) account with the Bank. These accounts will carry zero-balance facilities and no service charges until the completion of their academic programme. The Bank will also provide a dedicated Payment Gateway to facilitate online fee payments by all students. All these facilities are being extended free of cost as part of the Bank's Corporate Social Responsibility (CSR) initiative.

The Vice-Chancellor personally invited all the Members of Finance Committee to participate in the 38th Convocation to be held on 05.10.2025. He mentioned that around 2700 students will be receiving their Degrees with the A++ Grade which will be helpful for their higher studies and placements.

The Vice Chancellor requested the Secretary, Finance Committee to present the agenda items one by one to the august forum for discussion.

The Secretary, Finance Committee had made a presentation on the receipt of Grants and the Utilization to the Finance Committee. Further, he informed the Finance Committee that the MoE had given comments on the agenda items of the meeting and the same will be taken up on item-wise for discussion.

The Finance Committee considered and resolved to approve Grid Connected Solar Power Plant for GRI sanctioned by REC Foundation and the work executed by the RECPDCL.

Further, the Finance Committee authorizes the Vice-Chancellor to issue the required undertaking that under extraordinary circumstances, if it exceeds the granted amount it can be provided from the Institute's own resources, later the same can be replenished from the revenue generated from this project.

If happens so, the same may be dealt with the approval of the Finance Committee and the Board of Management.

To Consider and approve the Revised Budget Estimates for the Financial Year 2025-2026 and Budget Estimates for the Financial Year 2026-2027.

Dr. K. Ravichandran, Finance Officer i/c informed that the Institute is submitting its Revised Estimates and the Budget Estimates based on a need-based requirement of funds for the Institute. Further, a proposal has been submitted to the Ministry of Education under OH-35 (Creation of Capital Assets) and as instructed the DPR of the proposals will be submitted in due course.
