



The Students who have studied in the Gandhigram Rural Institute during 2010-2017 and earlier in CBCS (ie Dip./UG 2010-2016 and PG/PG Diploma 2010-2017) and have not completed their programmes of study (Diploma, UG, PG, PG Diploma) due to failure in one or more subjects are permitted to appear for the **special supplementary examinations**.
2. For writing the supplementary/arrear papers, they must fill-up the supplementary course/papers in the column provided in the Application form and they must pay the examination fees. While submitting the application on or before the last date, they must enclose the Bank challan in proof of remittance of fee. After the last date prescribed for the payment of Examination fee through Bank is over, **the students should not pay the fee.**
3. The supplementary examination fee must be paid in the **Registrar's Account No. 10000.**
4. Candidates who have already applied and paid the fees in response to the Exam Notification dt. 21.04.2022 need not apply and pay again.
